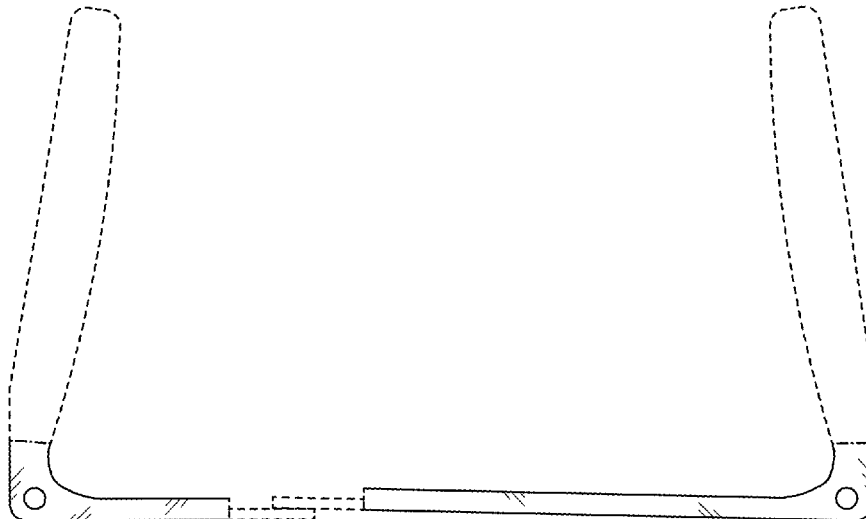
(57) **CLAIM**

The ornamental design for a double latch lever, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a double lever latch showing my new design, the left side elevational being a mirror image thereof;
FIG. 2 is a right side elevational view thereof, shown in an open position;
FIG. 3 is another right side elevational view thereof, shown in another open position;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a front elevational view thereof, the rear elevational view being a mirror image thereof.
The broken lines illustrate unclaimed portions and form no part of the claimed design.

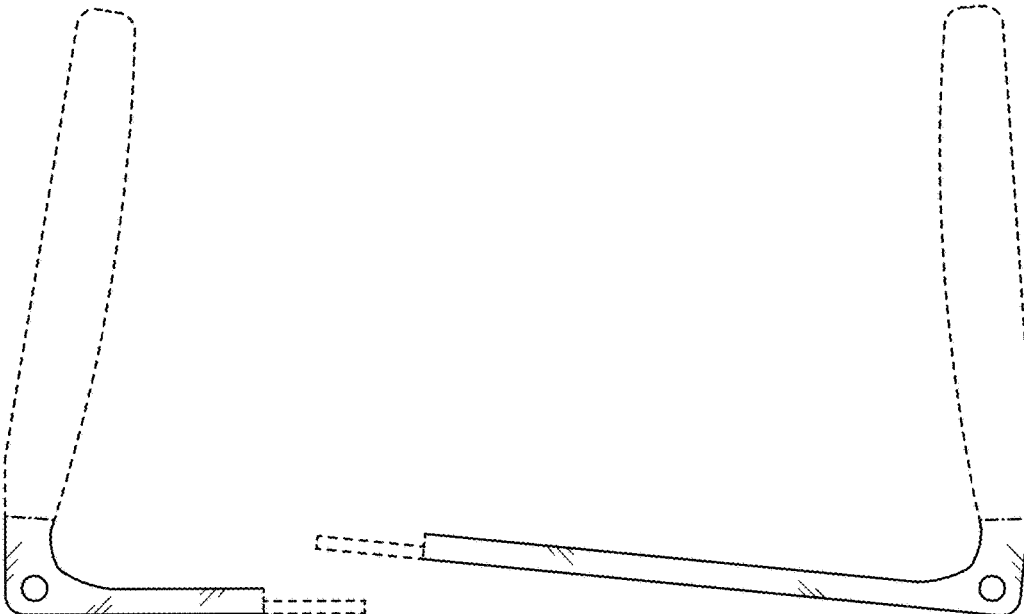

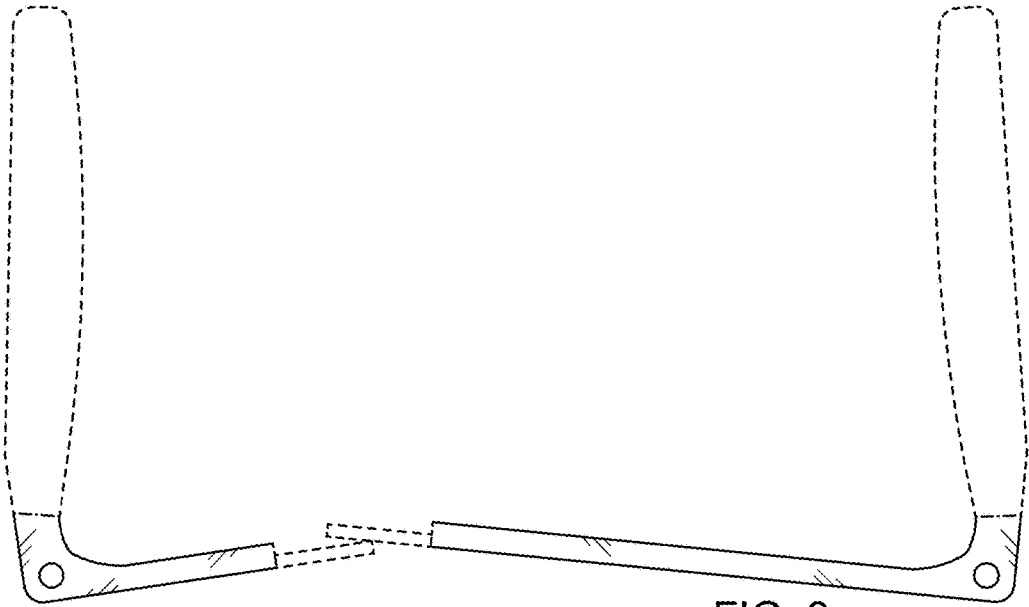

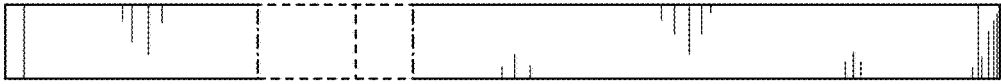
